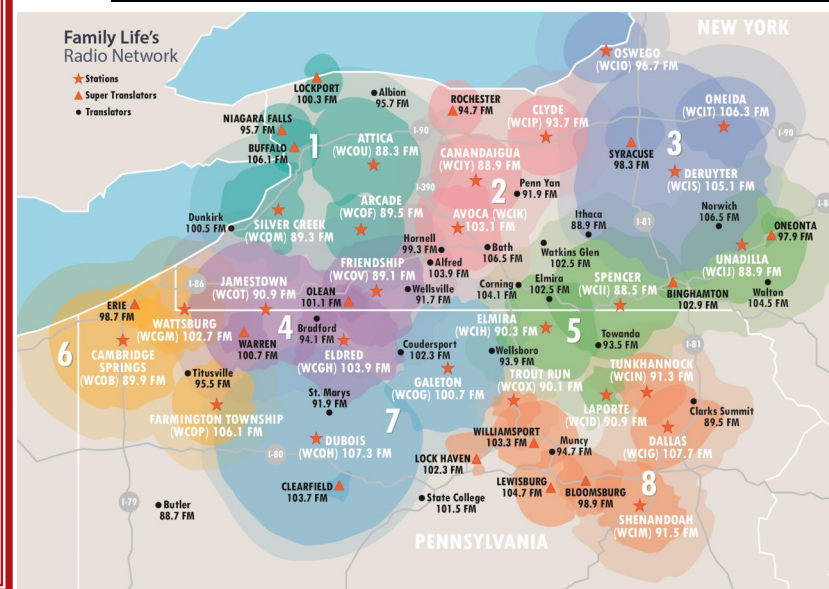

72 Hr Christmas Music Festival

Each year, at 12:01 AM on December 23rd, Family Life suspends regular programming and plays only Christmas music through midnight on December 25th, interspersed with Christmas greetings from businesses, churches and individuals. These greetings help to underwrite Christmas Music programming and can be aired across the network or in the region or regions of your choice. A few guidelines:

- Greetings are sold in sets (a set = 1 spot each day of 72 hr festival.)
- **Minimum of 3 sets (\$135)** for the *primary* region and **maximum of 7 sets per region**. You may choose to add sets in additional regions **after** meeting the minimum.
- There is a discount for any sets over the minimum—See order form above .
- Greetings should be about 15 seconds long. Fill out the information and we'll be glad to help write your spot.
